





Mozaik Foundation: A hub for youth engagement and social entrepreneurship in Bosnia

Overview

Mozaik Foundation (Mozaik) is the leading impact investor in the region, with a mission to identify, empower and invest in value-driven and innovative social entrepreneurs. Mozaik is committed to achieving its 10-year impact which states that: "Between 2016 and 2025 Mozaik will lead the development of a breakthrough generation of entrepreneurial and innovative youth – a value-driven force that creates new social and economic value, creates new jobs and serves as role model to other youth."




Mozaik was established in 2002. and since then over 21.000 volunteers and 4.300 individuals, business, NGOs and government offices joined forces to support over 2.100 youth-led community actions and register 13 social businesses.



Social Impact Incentives (SIINC): Scaling Inka Moss together with impact-first investors like elea Foundation

Overview

Inka Moss in Peru generates work for very low-income communities by harvesting “white moss” (*Sphagnum Magellanicum*). The plant grows wild in the Andes and has unique properties and high international demand, especially as an efficient natural substrate in horticulture (e.g. orchids).

To date, Inka Moss has incorporated 20 communities in its production chain, generating an impact for more than 15,000 people. Now, the enterprise intends to scale by expanding the number of communities as well as its harvest areas and production capacities.


SDC pre-orders impact from the Social Enterprise Inka Moss – and with this impact purchase agreement they become attractive for social investors (see detailed metrics on next slide)
